#### Abstract

The mild Itô formula proposed in Theorem 1 in [Da Prato, G., Jentzen, A., \& Röckner, M., A mild Itô formula for SPDEs, arXiv:1009.3526 (2012), To appear in the Trans. Amer. Math. Soc.] has turned out to be a useful instrument to study solutions and numerical approximations of stochastic partial differential equations (SPDEs) which are formulated as stochastic evolution equations (SEEs) on Hilbert spaces. In this article we generalize this mild Itô formula so that it is applicable to solutions and numerical approximations of SPDEs which are formulated as SEEs on UMD (unconditional martingale differences) Banach spaces. This generalization is especially useful for proving essentially sharp weak convergence rates for numerical approximations of SPDEs.

## 1 Introduction

The standard Itô formula for finite dimensional Itô processes has been generalized in the literature to infinite dimensions so that it is applicable to Itô processes with values in infinite dimensional Hilbert or Banach spaces; see Theorem 2.4 in Brzeźniak, Van Neerven, Veraar \& Weiss [1. This infinite dimensional generalization of the standard

Itô formula is, however, typically not applicable to a solution (or a numerical approximation) of a stochastic partial differential equation (SPDE) as solutions of SPDEs are often only solutions in the mild or weak sense, which are not Itô processes on the considered state space of the SPDE. To overcome this lack of regularity of solutions of SPDEs, Da Prato et al. proposed in Theorem 1 in [2] (see also [5, Section 5]) an alternative formula which Da Prato et al. refer to as a mild Itô formula. The mild Itô formula in Theorem 1 in [2] is (even in finite dimensions) different to the standard Itô formula but it applies to the class of Hilbert space valued mild Itô processes which is a rather general class of Hilbert space valued stochastic processes that includes standard Itô processes as well as mild solutions and numerical approximations of semilinear SPDEs as special cases. In this work we generalize the mild Itô formula so that it is applicable to mild Itô processes which take values in UMD (unconditional martingale differences) Banach spaces with type 2; see Definition 3.1 in Subsection 3.2, see Theorem 3.5 in Subsection 3.4, and see Corollary 3.8 in Subsection 3.4 below. This generalization of the mild Itô formula is especially useful for proving essentially sharp weak convergence rates for numerical approximations of SPDEs. In Section 2 below we also briefly review a few well-known results for Nemytskii and multiplication operators in Banach spaces (see Proposition 2.6, Proposition 2.10, and Corollary 2.11 in Section 2 below) which provide natural examples for the possibly nonlinear test function appearing in the mild Itô formula in Corollary 3.8 in Subsection 3.4 below.

### 1.1 Notation

Throughout this article the following notation is frequently used. Let $\mathbb{N}=\{1,2,3, \ldots\}$ be the set of natural numbers. Let $\mathbb{N}_{0}=\mathbb{N} \cup\{0\}$ be the union of $\{0\}$ and the set of natural numbers. For all sets $A$ and $B$ let $\mathbb{M}(A, B)$ be the set of all functions from $A$ to $B$. For all measurable spaces $\left(\Omega_{1}, \mathcal{F}_{1}\right)$ and $\left(\Omega_{2}, \mathcal{F}_{2}\right)$ let $\mathcal{M}\left(\mathcal{F}_{1}, \mathcal{F}_{2}\right)$ be the set of all $\mathcal{F}_{1} / \mathcal{F}_{2}$-measurable functions. For all separable $\mathbb{R}$-Hilbert spaces $\left(\stackrel{H}{H},\langle\cdot, \cdot\rangle_{\check{H}},\|\cdot\|_{\check{H}}\right)$ and $\left(\hat{H},\langle\cdot, \cdot\rangle_{\hat{H}},\|\cdot\|_{\hat{H}}\right)$ let $\mathcal{S}(\hat{H}, \check{H})$ be the sigma algebra on $L(\hat{H}, \check{H})$ given by $\mathcal{S}(\hat{H}, \check{H})=$ $\sigma_{L(\hat{H}, \check{H})}\left(\cup_{v \in \hat{H}} \cup_{\mathcal{A} \in \mathcal{B}(\check{H})}\{A \in L(\hat{H}, \check{H}): A v \in \mathcal{A}\}\right.$ ) (see, e.g., [3, Section 1.2]). For every $d \in \mathbb{N}$ and every $A \in \mathcal{B}\left(\mathbb{R}^{d}\right)$ let $\lambda_{A}: \mathcal{B}(A) \rightarrow[0, \infty]$ be the Lebesgue-Borel measure on $A$. For every set $X$ let $\#_{X} \in \mathbb{N}_{0} \cup\{\infty\}$ be the number of elements of $X$. For every measure space $(\Omega, \mathcal{F}, \nu)$, every measurable space $(S, \mathcal{S})$, every set $R$, and every function $f: \Omega \rightarrow R$ let $[f]_{\nu, \mathcal{S}}$ be the set given by $[f]_{\nu, \mathcal{S}}=\{g \in \mathcal{M}(\mathcal{F}, \mathcal{S}):(\exists A \in \mathcal{F}: \nu(A)=$ 0 and $\{\omega \in \Omega: f(\omega) \neq g(\omega)\} \subseteq A)\}$.

## 2 Stochastic partial differential equations in Banach spaces

In this section we recall a few well-known results for SPDEs on UMD Banach spaces. In particular, Proposition 2.6 below provides natural examples for the possibly nonlinear test function appearing in the mild Itô formula in Corollary 3.8 in Subsection 3.4 below.

### 2.1 Preliminary results

The following lemma and its proof can, e.g., be found in Van Neerven [8] (cf. [8, Theorem 6.2] and [8, Definition 3.7]).

Lemma 2.1 (An ideal property for $\gamma$-radonifying operators). Let $\left(U,\langle\cdot, \cdot\rangle_{U},\|\cdot\|_{U}\right)$ and $\left(\mathcal{U},\langle\cdot, \cdot\rangle_{\mathcal{U}},\|\cdot\|_{\mathcal{U}}\right)$ be $\mathbb{R}$-Hilbert spaces, let $\left(V,\|\cdot\|_{V}\right)$ and $\left(\mathcal{V},\|\cdot\|_{\mathcal{V}}\right)$ be $\mathbb{R}$-Banach spaces, and
let $A \in L(V, \mathcal{V}), B \in \gamma(U, V), C \in L(\mathcal{U}, U)$. Then it holds that $A B C \in \gamma(\mathcal{U}, \mathcal{V})$ and

$$
\begin{equation*}
\|A B C\|_{\gamma(\mathcal{U}, \mathcal{V})} \leq\|A\|_{L(V, \mathcal{V})}\|B\|_{\gamma(U, V)}\|C\|_{L(\mathcal{U}, U)} . \tag{1}
\end{equation*}
$$

The next result is an elementary extension of Brzeźniak et al. [1, Lemma 2.3].
Lemma 2.2. Consider the notation in Subsection 1.1 , let $\left(U,\langle\cdot, \cdot\rangle_{U},\|\cdot\|_{U}\right)$ be a separable $\mathbb{R}$-Hilbert space, let $\left(V,\|\cdot\|_{V}\right)$ and $\left(\mathcal{V},\|\cdot\|_{\mathcal{V}}\right)$ be $\mathbb{R}$-Banach spaces, and let $\beta \in L^{(2)}(V, \mathcal{V})$. Then
(i) it holds for all $A_{1}, A_{2} \in \gamma(U, V)$ and all orthonormal sets $\mathbb{U} \subseteq U$ of $U$ that there exists a unique $v \in \mathcal{V}$ such that

\inf _{\substack{I \subseteq, \# \subseteq<\infty \\ I \subseteq J \subseteq \mathbb{I} \\ \# J<\infty}} \sup _{\substack{ \\\hline}}\left\|v-\sum_{u \in J} \beta\left(A_{1} u, A_{2} u\right)\right\|_{\mathcal{V}}=0, \tag{2}
\end{equation*}

(ii) it holds for all orthonormal bases $\mathbb{U}_{1}, \mathbb{U}_{2} \subseteq U$ of $U$ that

\begin{equation*}
\sum_{u \in \mathbb{U}_{1}} \beta\left(A_{1} u, A_{2} u\right)=\sum_{u \in \mathbb{U}_{2}} \beta\left(A_{1} u, A_{2} u\right), \tag{3}
\end{equation*}
$$

(iii) it holds for all $A_{1}, A_{2} \in \gamma(U, V)$ and all orthonormal sets $\mathbb{U} \subseteq U$ of $U$ that

\left\|\sum_{u \in \mathbb{U}} \beta\left(A_{1} u, A_{2} u\right)\right\|_{\mathcal{V}} \leq\|\beta\|_{L^{(2)}(V, \mathcal{V})}\left\|A_{1}\right\|_{\gamma(U, V)}\left\|A_{2}\right\|_{\gamma(U, V)} \tag{4}
\end{equation*}

and
(iv) it holds for all orthonormal sets $\mathbb{U} \subseteq U$ of $U$ that

\left(\gamma(U, V) \times \gamma(U, V) \ni\left(A_{1}, A_{2}\right) \mapsto \sum_{u \in \mathbb{U}} \beta\left(A_{1} u, A_{2} u\right) \in \mathcal{V}\right) \in L^{(2)}(\gamma(U, V), \mathcal{V}) \tag{5}
\end{equation*}

### 2.2 Convergence properties of measurable functions

Lemma 2.3 (A characterization for convergence in measure). Let $(\Omega, \mathcal{F}, \nu)$ be a $f i$ nite measure space and let $R_{n}: \Omega \rightarrow \mathbb{R}, n \in \mathbb{N}=\{1,2, \ldots\}$, be $\mathcal{F} / \mathcal{B}(\mathbb{R})$-measurable functions. Then the following two statements are equivalent:
(i) It holds that

\limsup _{n \rightarrow \infty} \int_{\Omega} \min \left\{1,\left|R_{n}\right|\right\} d \nu=0 \tag{6}
\end{equation*}
$$

(ii) For every strictly increasing function $n: \mathbb{N} \rightarrow \mathbb{N}$ there exists a strictly increasing function $m: \mathbb{N} \rightarrow \mathbb{N}$ such that

\nu\left(\left\{\omega \in \Omega: \limsup _{k \rightarrow \infty}\left|R_{n(m(k))}(\omega)\right|>0\right\}\right)=0 . \tag{7}
\end{equation*}

Lemma 2.4. Let $(\Omega, \mathcal{F}, \nu)$ be a finite measure space, let $(E, d)$ and $(\mathcal{E}, \delta)$ be separable pseudometric spaces, let $\phi: E \rightarrow \mathcal{E}$ be a continuous function, and let $f_{n}: \Omega \rightarrow E$, $n \in\{0,1,2, \ldots\}$, be $\mathcal{F} / \mathcal{B}(E)$-measurable functions which satisfy

$$
\begin{equation*}
\limsup _{n \rightarrow \infty} \int_{\Omega} \min \left\{1, d\left(f_{n}, f_{0}\right)\right\} d \nu=0 \tag{8}
\end{equation*}
$$

Then

$$
\begin{equation*}
\limsup _{n \rightarrow \infty} \int_{\Omega} \min \left\{1, \delta\left(\phi \circ f_{n}, \phi \circ f_{0}\right)\right\} d \nu=0 . \tag{9}
\end{equation*}
$$

Proof of Lemma 2.4. Observe that Lemma 2.3 and the assumption that

\limsup _{n \rightarrow \infty} \int_{\Omega} \min \left\{1, d\left(f_{n}, f_{0}\right)\right\} d \nu=0 \tag{10}
\end{equation*}
$$

ensure that for every strictly increasing function $n: \mathbb{N} \rightarrow \mathbb{N}$ there exists a strictly increasing function $m: \mathbb{N} \rightarrow \mathbb{N}$ such that

$$
\begin{equation*}
\nu\left(\left\{\omega \in \Omega: \limsup _{k \rightarrow \infty} d\left(f_{n(m(k))}(\omega), f_{0}(\omega)\right)>0\right\}\right)=0 \tag{11}
\end{equation*}
$$

The assumption that $\phi$ is continuous hence shows that for every strictly increasing function $n: \mathbb{N} \rightarrow \mathbb{N}$ there exists a strictly increasing function $m: \mathbb{N} \rightarrow \mathbb{N}$ such that

\nu\left(\left\{\omega \in \Omega: \limsup _{k \rightarrow \infty} \delta\left(\phi\left(f_{n(m(k))}(\omega)\right), \phi\left(f_{0}(\omega)\right)\right)>0\right\}\right)=0 \tag{12}
\end{equation*}
$$

Combining this with Lemma 2.3 completes the proof of Lemma 2.4 .
Corollary 2.5. Let $(\Omega, \mathcal{F}, \nu)$ be a finite measure space, let $(E, d)$ and $(\mathcal{E}, \delta)$ be separable pseudometric spaces, let $p, q \in(0, \infty)$, let $\phi: E \rightarrow \mathcal{E}$ be a continuous and globally bounded function, and let $f_{n}: \Omega \rightarrow E, n \in\{0,1,2, \ldots\}$, be $\mathcal{F} / \mathcal{B}(E)$-measurable functions which satisfy $\lim \sup _{n \rightarrow \infty} \int_{\Omega}\left|d\left(f_{n}, f_{0}\right)\right|^{p} d \nu=0$. Then

$$
\begin{equation*}
\underset{n \rightarrow \infty}{\limsup } \int_{\Omega}\left|\delta\left(\phi \circ f_{n}, \phi \circ f_{0}\right)\right|^{q} d \nu=0 . \tag{13}
\end{equation*}
$$

Proof of Corollary 2.5. Observe that the assumption that $\limsup _{n \rightarrow \infty} \int_{\Omega}\left|d\left(f_{n}, f_{0}\right)\right|^{p} d \nu=$ 0 and Hölder's inequality ensure that $\limsup _{n \rightarrow \infty} \int_{\Omega}\left|d\left(f_{n}, f_{0}\right)\right|^{\min \{p, 1\}} d \nu=0$. Hence, we obtain that

$$
\begin{equation*}
\limsup _{n \rightarrow \infty} \int_{\Omega} \min \left\{1, d\left(f_{n}, f_{0}\right)\right\} d \nu \leq \limsup _{n \rightarrow \infty} \int_{\Omega}\left|\min \left\{1, d\left(f_{n}, f_{0}\right)\right\}\right|^{\min \{p, 1\}} d \nu=0 . \tag{14}
\end{equation*}
$$

This allows us to apply Lemma 2.4 to obtain that

$$
\begin{equation*}
\limsup _{n \rightarrow \infty} \int_{\Omega} \min \left\{1, \delta\left(\phi \circ f_{n}, \phi \circ f_{0}\right)\right\} d \nu=0 . \tag{15}
\end{equation*}
$$

The fact that the function $[0, \infty) \ni x \mapsto|x|^{q} \in[0, \infty)$ is continuous and again Lemma 2.4 hence show that

\limsup _{n \rightarrow \infty} \int_{\Omega} \min \left\{1,\left|\delta\left(\phi \circ f_{n}, \phi \circ f_{0}\right)\right|^{q}\right\} d \nu=0 \tag{16}
\end{equation*}

Combining this and, e.g., Klenke [7, Corollary 6.26] with the fact that $\sup (\{\mid \delta((\phi \circ$ $\left.\left.\left.\left.f_{n}\right)(\omega),\left(\phi \circ f_{0}\right)(\omega)\right)\left.\right|^{p}: \omega \in \Omega, n \in \mathbb{N}\right\} \cup\{0\}\right)<\infty$ ensures that

\begin{equation*}
\limsup _{n \rightarrow \infty} \int_{\Omega}\left|\delta\left(\phi \circ f_{n}, \phi \circ f_{0}\right)\right|^{q} d \nu=0 . \tag{17}
\end{equation*}
$$

The proof of Corollary 2.5 it thus completed.

### 2.3 Regular test functions

Proposition 2.6. Consider the notation in Subsection 1.1, let $k, l$, $d, n \in \mathbb{N}, p \in[1, \infty)$, $q \in(n p, \infty)$, let $\mathcal{O} \in \mathcal{B}\left(\mathbb{R}^{d}\right)$ be a bounded set, let $f: \mathbb{R}^{k} \rightarrow \mathbb{R}^{l}$ be an $n$-times continuously differentiable function with globally bounded derivatives, and let $F: L^{q}\left(\lambda_{\mathcal{O}} ; \mathbb{R}^{k}\right) \rightarrow$ $L^{p}\left(\lambda_{\mathcal{O}} ; \mathbb{R}^{l}\right)$ be the function which satisfies for all $v \in \mathcal{L}^{q}\left(\lambda_{\mathcal{O}} ; \mathbb{R}^{k}\right)$ that

F\left([v]_{\lambda_{\mathcal{O}}, \mathcal{B}\left(\mathbb{R}^{l}\right)}\right)=\left[\{f(v(x))\}_{x \in \mathcal{O}}\right]_{\lambda_{\mathcal{O}}, \mathcal{B}\left(\mathbb{R}^{l}\right)}=[f \circ v]_{\lambda_{\mathcal{O}}, \mathcal{B}\left(\mathbb{R}^{l}\right)} . \tag{18}

(i) it holds that $F$ is n-times continuously Fréchet differentiable with globally bounded derivatives,
(ii) it holds for all $m \in\{1,2, \ldots, n\}, v, u_{1}, \ldots, u_{m} \in \mathcal{L}^{q}\left(\lambda_{\mathcal{O}} ; \mathbb{R}^{k}\right)$ that

Proof of Proposition [2.6. Throughout this proof we assume w.l.o.g. that $\lambda_{\mathbb{R}^{d}}(\mathcal{O})>0$. We claim that for all $m \in\{1,2, \ldots, n\}$ it holds

Observe that for all $v \in L^{\max \{p, 4\}}\left(\lambda_{(0,1)^{d}} ; \mathbb{R}\right), u \in L^{4}\left(\lambda_{(0,1)^{d}} ; \mathbb{R}\right)$ it holds that

(iii) it holds that

\end{equation*}

Moreover, we note that Hölder's inequality shows that for all $u, v \in L^{2 p}\left(\lambda_{(0,1)} ; \mathbb{R}\right)$ it holds that

& =\sup _{v_{1}, \ldots, v_{k} \in V \backslash\{0\}} \frac{\left\|\iota M\left(\psi^{(k)}(v)\left(v_{1}, \ldots, v_{k}\right)\right)\right\|_{\gamma\left(H, V_{\beta}\right)}}{\left\|v_{1}\right\|_{V} \ldots \ldots \cdot\left\|v_{k}\right\|_{V}}  \tag{95}\\
& \leq\|\iota M\|_{L\left(L^{p / / n}\left(\lambda_{(0,1)} ; \mathbb{R}\right), \gamma\left(H, V_{\beta}\right)\right)} \sup _{v_{1}, \ldots, v_{k} \in V \backslash\{0\}} \frac{\left\|\psi^{(k)}(v)\left(v_{1}, \ldots, v_{k}\right)\right\|_{L^{p \delta / n}\left(\lambda_{(0,1) ; \mathbb{R})}\right.}}{\left\|v_{1}\right\|_{V} \cdot \ldots \cdot\left\|v_{k}\right\|_{V}} \\

This and (77) ensure that for all $k \in\{1, \ldots, n\}$ it holds that

& \quad \cdot\left[\sup _{w \in H_{n /(2 p \delta) \backslash\{0\}}} \frac{\|w\|_{L^{2 p \delta /(p \delta \delta-2 n)}\left(\lambda_{(0,1)} ; \mathbb{R}\right)}}{\|w\|_{H_{n /(2 p \delta)}}}\right]\left[\sup _{x \in \mathbb{R}}\left|b^{(k)}(x)\right|\right]<\infty .
\end{align*}

& \leq\|\iota M\|_{L\left(L^{p \delta / n}\left(\lambda_{(0,1)} ; \mathbb{R}\right), \gamma\left(H, V_{\beta}\right)\right)} \frac{\left\|\left[\psi^{(k)}(v)-\psi^{(k)}(w)\right]\left(v_{1}, \ldots, v_{k}\right)\right\|_{L^{p \delta / n}\left(\lambda_{(0,1)} ; \mathbb{R}\right)}}{\left\|v_{1}\right\|_{V} \cdot \ldots \cdot\left\|v_{k}\right\|_{V}} \\
& \leq\|\iota M\|_{L\left(L^{p \delta / n}\left(\lambda_{(0,1)} ; \mathbb{R}\right), \gamma\left(H, V_{\beta}\right)\right)}\left\|\psi^{(k)}(v)-\psi^{(k)}(w)\right\|_{L^{(k)}\left(V, L^{p \delta / n}\left(\lambda_{(0,1) ; \mathbb{R}))} .\right.\right.}
\end{align*}
$$

This, (78), and (90) assure that for all $k \in\{1, \ldots, n\}, r \in\left[\frac{p \delta}{n-k \delta}, \infty\right)$ it holds that

& \sup _{\substack{v, w \in L^{\max \{r, p\}}\left(\lambda_{(0,1)} ; \mathbb{R}\right),}}\left[\frac{\left\|B^{(k)}(v)-B^{(k)}(w)\right\|_{L^{(k)}\left(V, \gamma\left(H, V_{\beta}\right)\right)}}{\|v-w\|_{L^{r}\left(\lambda_{(0,1)} ; \mathbb{R}\right)}}\right] \\
& \leq\|\iota M\|_{L\left(L^{p \delta / n}\left(\lambda_{(0,1)} ; \mathbb{R}\right), \gamma\left(H, V_{\beta}\right)\right)}\left[\sup _{\substack{x, y \in \mathbb{R}, x \neq y}} \frac{\left|b^{(k)}(x)-b^{(k)}(y)\right|}{|x-y|}\right]  \tag{99}\\
& \leq\|\iota\|_{\gamma\left(H_{\left.-n /(2 p \delta), V_{\beta}\right)}\|M\|_{L\left(L^{p \delta / n}\left(\lambda_{(0,1)} ; \mathbb{R}\right), L\left(H, H_{-n /(2 p \delta)))}\right.\right.}\left[\sup _{\substack{x, y \in \mathbb{R}, x \neq y}} \frac{\left|b^{(k)}(x)-b^{(k)}(y)\right|}{|x-y|}\right] .\right.} .

Combining (99) with (88) and (83) establishes item (v). The proof of Proposition 2.10 is thus completed.

Corollary 2.11. Consider the notation in Subsection 1.1, let $n \in \mathbb{N}, \beta \in(-\infty,-1 / 4)$, $p \in\left(\max \left\{\frac{n+1}{2(|\beta|-1 / 4)}, 2(n+1)\right\}, \infty\right),\left(V,\|\cdot\|_{V}\right)=\left(L^{p}\left(\lambda_{(0,1)} ; \mathbb{R}\right),\|\cdot\|_{L^{p}\left(\lambda_{(0,1)} ; \mathbb{R}\right)}\right)$, let $b: \mathbb{R} \rightarrow \mathbb{R}$ be an n-times continuously differentiable function with globally Lipschitz continuous and globally bounded derivatives, let $A: D(A) \subseteq V \rightarrow V$ be the Laplacian with Dirichlet boundary conditions on $V$, and let $\left(V_{r},\|\cdot\|_{V_{r}}\right), r \in \mathbb{R}$, be a family of interpolation spaces associated to $-A$. Then
(i) there exists a unique continuous function $B: V \rightarrow \gamma\left(L^{2}\left(\lambda_{(0,1)} ; \mathbb{R}\right), V_{\beta}\right)$ which satisfies for all $v, u \in \mathcal{L}^{2 p}\left(\lambda_{(0,1)} ; \mathbb{R}\right)$ that

B\left([v]_{\lambda_{(0,1)}, \mathcal{B}(\mathbb{R})}\right)[u]_{\lambda_{(0,1)}, \mathcal{B}(\mathbb{R})}=\left[\{b(v(x)) \cdot u(x)\}_{x \in(0,1)}\right]_{\lambda_{(0,1)}, \mathcal{B}(\mathbb{R})} \tag{100}
\end{equation*}
$$

and
(ii) it holds that B is n-times continuously Fréchet differentiable with globally Lipschitz continuous and globally bounded derivatives.

Proof of Corollary 2.11. First, note that for all $k \in\{1,2, \ldots, n\}$ it holds that

Items (i), (iii), (iiii), and (v) of Proposition 2.10 (with $n=n, \beta=\beta, p=p, b=b$, $\mathcal{A}=A, k=n, \delta=\frac{n}{(n+1)}, r=p$ in the notation of Proposition 2.10) therefore establish items (ii) and (iii). The proof of Corollary 2.11 is thus completed.

## 3 Mild stochastic calculus in Banach spaces

In this section we generalize the machinery in [5, Section 5] from separable Hilbert spaces to separable UMD Banach spaces with type 2.

### 3.1 Setting

Throughout this section we frequently assume the following setting. Consider the notation in Subsection 1.1, let $t_{0} \in[0, \infty), T \in\left(t_{0}, \infty\right), \angle=\left\{\left(t_{1}, t_{2}\right) \in\left[t_{0}, T\right]^{2}: t_{1}<t_{2}\right\}$, let $(\Omega, \mathcal{F}, \mathbb{P})$ be a probability space with a normal filtration $\mathbb{F}=\left(\mathbb{F}_{t}\right)_{t \in\left[t_{0}, T\right]}$, let $\left(W_{t}\right)_{t \in\left[t_{0}, T\right]}$ be an $\operatorname{Id}_{U}$-cylindrical $(\Omega, \mathcal{F}, \mathbb{P}, \mathbb{F})$-Wiener process, let $\left(\check{V},\|\cdot\|_{\check{V}}\right),\left(V,\|\cdot\|_{V}\right),\left(\hat{V},\|\cdot\| \|_{\hat{V}}\right)$, and $\left(\mathcal{V},\|\cdot\|_{V}\right)$ be separable UMD $\mathbb{R}$-Banach spaces with type 2 which satisfy $\hat{V} \subseteq$ $V \subseteq \hat{V}$ continuously and densely, let $\left(U,\langle\cdot, \cdot\rangle_{U},\|\cdot\|_{U}\right)$ be a separable $\mathbb{R}$-Hilbert space, let $\mathbb{U} \subseteq U$ be an orthonormal basis of $U$, and for every separable $\mathbb{R}$-Banach space $\left(E,\|\cdot\|_{E}\right)$ and every $a, b \in \mathbb{R}, A \in \mathcal{B}(\mathbb{R}), X \in \mathcal{M}(\mathcal{B}(A) \otimes \mathcal{F}, \mathcal{B}(E))$ with $a<b$, $(a, b) \subseteq A$, and $\mathbb{P}\left(\int_{a}^{b}\left\|X_{s}\right\|_{E} d s<\infty\right)=1$ let $\int_{a}^{b} X_{s} \mathbf{d s} \in L^{0}(\mathbb{P} ; E)$ be given by $\int_{a}^{b} X_{s} \mathbf{d s}=\left[\int_{a}^{b} \mathbb{1}_{\left\{\int_{a}^{b}\left\|X_{u}\right\|_{E} d u<\infty\right\}} X_{s} d s\right]_{\mathbb{P}, \mathcal{B}(E)}$.

### 3.2 Mild Itô processes

Definition 3.1 (Mild Itô process). Consider the notation in Subsection 1.1, let $\left(\check{V},\|\cdot\|_{\check{V}}\right)$, $\left(V,\|\cdot\|_{V}\right)$, and $\left(\hat{V},\|\cdot\|_{\hat{V}}\right)$ be separable UMD $\mathbb{R}$-Banach spaces with type 2 which satisfy $\check{V} \subseteq V \subseteq \hat{V}$ continuously and densely, let $\left(U,\langle\cdot, \cdot\rangle_{U},\|\cdot\|_{U}\right)$ be a separable $\mathbb{R}$-Hilbert space, let $t_{0} \in[0, \infty), T \in\left(t_{0}, \infty\right)$, let $(\Omega, \mathcal{F}, \mathbb{P})$ be a probability space with a normal filtration $\mathbb{F}=\left(\mathbb{F}_{t}\right)_{t \in\left[t t_{0}, T\right]}$, and let $\left(W_{t}\right)_{t \in[t, T]}$ be an $\operatorname{Id}_{U}$-cylindrical $(\Omega, \mathcal{F}, \mathbb{P}, \mathbb{F})$ Wiener process. Then we say that $X$ is a mild Itô process on $\left(\Omega, \mathcal{F}, \mathbb{P}, \mathbb{F}, W,\left(\check{V},\|\cdot\|_{\check{V}}\right)\right.$, $\left(V,\|\cdot\|_{V}\right),\left(\hat{V},\|\cdot\|_{\hat{V}}\right)$ ) with evolution family $S$, mild drift $Y$, and mild diffusion $Z$ (we say that $X$ is a mild Itô process with evolution family $S$, mild drift $Y$, and mild diffusion $Z$, we say that $X$ is a mild Itô process) if and only if it holds
(i) that $X \in \mathbb{M}\left(\left[t_{0}, T\right] \times \Omega, V\right)$ is an $\mathbb{F} / \mathcal{B}(V)$-predictable stochastic process,
(ii) that $Y \in \mathbb{M}\left(\left[t_{0}, T\right] \times \Omega, \hat{V}\right)$ is an $\mathbb{F} / \mathcal{B}(\hat{V})$-predictable stochastic process,
(iii) that $Z \in \mathbb{M}\left(\left[t_{0}, T\right] \times \Omega, \gamma(U, \hat{V})\right)$ is an $\mathbb{F} / \mathcal{B}(\gamma(U, \hat{V}))$-predictable stochastic process,
(iv) that $S \in \mathbb{M}\left(\left\{\left(t_{1}, t_{2}\right) \in\left[t_{0}, T\right]^{2}: t_{1}<t_{2}\right\}, L(\hat{V}, \check{V})\right)$ is a $\mathcal{B}\left(\left\{\left(t_{1}, t_{2}\right) \in\left[t_{0}, T\right]^{2}: t_{1}<t_{2}\right\}\right) /$ $\mathcal{S}(\hat{V}, \check{V})$-measurable function which satisfies for all $t_{1}, t_{2}, t_{3} \in\left[t_{0}, T\right]$ with $t_{1}<t_{2}<$ $t_{3}$ that $S_{t_{2}, t_{3}} S_{t_{1}, t_{2}}=S_{t_{1}, t_{3}}$,
(v) that $\forall t \in\left(t_{0}, T\right]: \mathbb{P}\left(\int_{t_{0}}^{t}\left\|S_{s, t} Y_{s}\right\|_{\check{V}}+\left\|S_{s, t} Z_{s}\right\|_{\gamma(U, \check{V})}^{2} d s<\infty\right)=1$, and
(vi) that for all $t \in\left(t_{0}, T\right]$ it holds that

\left[X_{t}\right]_{\mathbb{P}, \mathcal{B}(V)}=\left[S_{t_{0}, t} X_{t_{0}}+\int_{t_{0}}^{t} \mathbb{1}_{\left\{\int_{t_{0}}^{t}\left\|S_{s, t} Y_{s}\right\|_{V} d s<\infty\right\}} S_{s, t} Y_{s} d s\right]_{\mathbb{P}, \mathcal{B}(V)}+\int_{t_{0}}^{t} S_{s, t} Z_{s} d W_{s} . \tag{103}
\end{equation*}

Lemma 3.2 (Regularization of mild Itô processes). Assume the setting in Subsection 3.1 and let $X:\left[t_{0}, T\right] \times \Omega \rightarrow V$ be a mild Itô process with evolution family $S: \angle \rightarrow$ $L(\hat{V}, \hat{V})$, mild drift $Y:\left[t_{0}, T\right] \times \Omega \rightarrow \hat{V}$, and mild diffusion $Z:\left[t_{0}, T\right] \times \Omega \rightarrow \gamma(U, \hat{V})$. Then there exists an up to indistinguishability unique stochastic process $\bar{X}:\left[t_{0}, T\right] \times \Omega \rightarrow$ $\check{V}$ with continuous sample paths which satisfies $\forall t \in\left[t_{0}, T\right): \mathbb{P}\left(\bar{X}_{t}=S_{t, T} X_{t}\right)=1$.

Proof of Lemma 3.2. The assumption that $X$ is a mild Itô process, in particular, ensures that $\mathbb{P}\left(\int_{t_{0}}^{T}\left\|S_{s, T} Y_{s}\right\|_{\check{V}}+\left\|S_{s, T} Z_{s}\right\|_{\gamma(U, \check{V})}^{2} d s<\infty\right)=1$. This implies that there exists
a stochastic process $\bar{X}:\left[t_{0}, T\right] \times \Omega \rightarrow \check{V}$ with continuous sample paths which satisfies for all $t \in\left[t_{0}, T\right]$ that

Assume the setting in Subsection[3.1, let $X:\left[t_{0}, T\right] \times \Omega \rightarrow V$ be a mild Itô process with evolution family $S: \angle \rightarrow L(\hat{V}, \check{V})$, mild drift $Y:\left[t_{0}, T\right] \times \Omega \rightarrow \hat{V}$, and mild diffusion $Z:\left[t_{0}, T\right] \times \Omega \rightarrow \gamma(U, \hat{V})$, let $\bar{X}:\left[t_{0}, T\right] \times \Omega \rightarrow \bar{V}$ be a stochastic process with continuous sample paths which satisfies $\forall t \in\left[t_{0}, T\right): \mathbb{P}\left(\bar{X}_{t}=S_{t, T} X_{t}\right)=1$ (see Lemma 3.2), let $\varphi \in C^{2}(\check{V}, \mathcal{V})$, and let $\tau: \Omega \rightarrow\left[t_{0}, T\right]$ be an $\mathbb{F}$-stopping time. ### 3.5 Mild Dynkin-type formula

Under suitable additional assumptions (see Corollary 3.9 below), the stochastic integral in (iii) is integrable and centered. This is the subject of the following result.

& \mathbb{E}\left[\sup _{t \in\left[t_{0}, T\right]}\left\|\varphi\left(\bar{X}_{t}\right)\right\|_{\mathcal{V}}\right] \leq C\left(1+\mathbb{E}\left[\left\|S_{t_{0}, T} X_{t_{0}}\right\|_{\check{V}}^{p}\right]\right. \\
& \left.+\mathbb{E}\left[\left|\int_{t_{0}}^{T}\left\|S_{s, T} Y_{s}\right\|_{\check{V}} d s\right|^{p}\right]+\mathbb{E}\left[\left|\int_{t_{0}}^{T}\left\|S_{s, T} Z_{s}\right\|_{\gamma(U, \check{V})}^{2} d s\right|^{p / 2}\right]\right) \tag{144}
\end{align*}
$$

The assumption that $\mathbb{E}\left[\left\|S_{t_{0}, T} X_{t_{0}}\right\|_{\check{V}}^{p}+\left|\int_{t_{0}}^{T}\left\|S_{s, T} Y_{s}\right\|_{\check{V}} d s\right|^{p}+\left|\int_{t_{0}}^{T}\left\|S_{s, T} Z_{s}\right\|_{\gamma(U, \check{V})}^{2} d s\right|^{p / 2}\right]<$ $\infty$ hence ensures that

$$
\begin{equation*}
\mathbb{E}\left[\sup _{t \in\left[t_{0}, T\right]}\left\|\varphi\left(\bar{X}_{t}\right)\right\|_{V}\right]<\infty \tag{145}
\end{equation*}
$$

Lemma 3.3 therefore proves that

$$
\begin{equation*}
\mathbb{E}\left[\sup _{t \in\left[t_{0}, T\right]}\left\|\varphi\left(S_{t_{0}, T} X_{t_{0}}+\int_{t_{0}}^{t} S_{s, T} Y_{s} \mathbb{1}_{\left\{\int_{t_{0}}^{T}\left\|S_{r, T} Y_{r}\right\|_{\bar{V}} d r<\infty\right\}} d s+\mathcal{Z}_{t}\right)\right\|_{\mathcal{V}}\right]<\infty \tag{146}
\end{equation*}
$$

Combining this with Proposition 3.10 completes the proof of Proposition 3.11.
